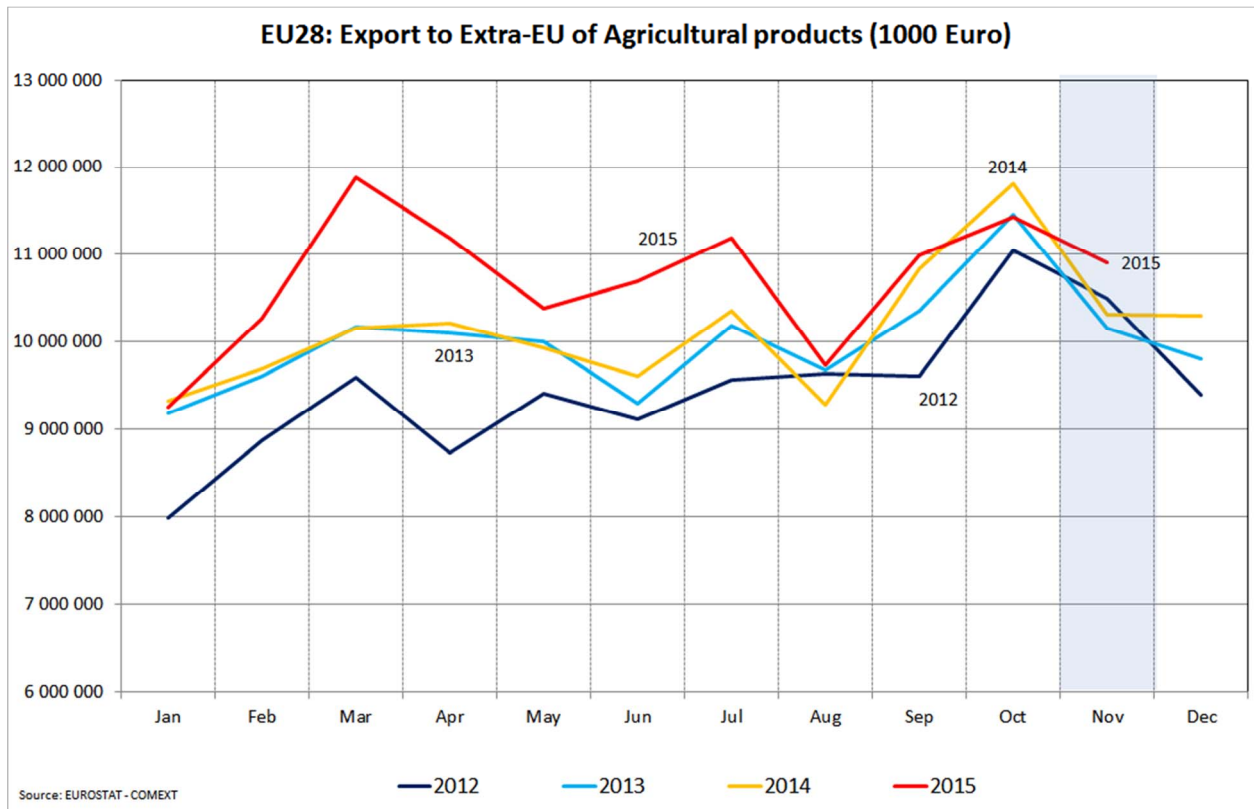


Monitoring EU Agri-Food Trade: Development until November 2015



November 2015 - EU agri-food exports higher than in previous years

EU agri-food exports in November 2015 achieved a value of EUR 10.9 billion, thus exceeding the value of previous years for the same month by about EUR 500 million. While export values went down slightly compared to October 2015, this is fully in line with the normal seasonal development. Most reductions on monthly basis were recorded for the "big" destinations, i.e. the USA, Japan and Canada, while the most important increases were in exports to Egypt, Israel and Switzerland.

The highest increases in monthly export values were witnessed for **vegetables** and **citrus fruit** (EUR +78 million and EUR +46 million) as well as for **wheat** (EUR +50 million) and for **live**

animals (EUR +45 million). On the other hand, monthly export values went down in particular for **wine** (EUR -160 million) and for **spirits** (EUR -130 million).

In November 2015 agri-food **imports** to the EU remained at EUR 9.5 billion, the same level as in October. Imports of tropical and other fruit, as well as cereals other than wheat, went up, while imports of oilcakes and citrus fruit went down. Imports increased in particular from US and from Ukraine, while imports from Argentina went down.

The **trade balance** for all EU agri-food products in November 2015 showed a surplus in exports of about EUR 1.3 billion.

12-month period: Exports still at record level

In the 12 months period December 2014 - November 2015, EU agri-food exports to third countries attained the amount of more than EUR 128 billion, meaning an increase by 5.7% in value compared to the same period one year ago. Outstanding export values were achieved in October 2014 and in March and July 2015.

Over the 12 months period, major gains in export values were achieved in the **USA** (+18%) **China** (+41%), now second export destination taking the place of Russia, as well as on other key markets such as **Saudi Arabia** (+32%), **Turkey** (+21%) and **South Korea** (+15%). Exports to Switzerland, Australia, Egypt and the United Arab Emirates also increased in the 12 months Dec. 2014 – Nov. 2015 compared to the same period one year ago. Due to the embargo, **Russia** fell down to fourth position and overall EU agri-food exports to Russia decreased from EUR 9.5 billion to EUR 5.6 billion (-41%) over the considered period.

Analysing the 12 months export performance per product category, export values increased in particular for **cereals** other than wheat (EUR +1.2 billion; +70%), **wine** (EUR +862 million; +9%), **spirits and liqueurs** (EUR +668 million; +7%) as well as for **raw hides, skins and furskins** (EUR +578 million; +25%), for **live animals** (EUR +480 million; +25%) and for beer, waters and soft drinks and infant food and other milk and cereals preparations.

On the negative side, **milk powders, cheese, fruit** and **vegetables** lost in export values over the 12 months period, all of them products concerned by the Russian embargo. Also exports in oilseeds other than soyabeans (-17%) and wheat (-4%) suffered a loss in export values, although at lower absolute value compared to the products mentioned before.

EU Agri-Food Imports: slight increase over last 12 months

In the period December 2014 - November 2015 total agri-food imports from third countries amounted to more than EUR 112 billion, corresponding to an increase by 8.5% compared to the same period one year ago.

Analysing the origin, imports from **Brazil**, the traditional first EU supplier, remained quite stable, with a slight increase by 2% in November 2015 compared to October. Imports from the **USA**, which is already the second most important supplier, further increased (EUR +1.4 billion; +14%) over the last 12 months. Remarkable increases were recorded for agri-food imports from **Turkey** (EUR +902 million; +22%), **Argentina** (EUR +532 million; +10%), **Vietnam** (EUR +397 million; +22%), and from **Colombia** (EUR +370 million; +22%). On the other hand, imports from **Ukraine** decreased by EUR 300 million (-7.5%) in the 12 months period, albeit with an impressive recovery in November 2015 (EUR +111 million) compared to October 2015.

Analysing 12-month-data per product category, total imports of commodities in value terms remained almost stable (-0.7%), but, in detail, imports of **cereals** other than wheat and rice decreased remarkably (EUR -931 million; -30%), as well as: **soybeans** (EUR -424 million; -8%), **oilcakes** (EUR -329 million; -4%) and beet and cane **sugar** (EUR -381 million; -23%). On the other hand, imports of unroasted **coffee**, tea and mate, increased sizeably (EUR +1.4 billion; +20%) as well as imports of **wheat** and **cocoa beans**.

For products other than commodities, increases were registered in particular for **tropical fruit, nuts** and **spices** (EUR +2.8 billion; +27%), fruit and vegetable preparations (EUR +777 million; +26%), olive oil (EUR +777 million; +25%) as well as fresh fruit (EUR +651 million; +12%), fresh vegetables (EUR +318 million; +8%), and raw tobacco (EUR +349 million; +15%).

Focus on: EU imports of tropical fruit, nuts and spices

In 2014, the EU imported tropical fruit, nuts and spice for a value of almost EUR 10.4 billion, representing a share of 10% of all EU agri-food imports. Values increased steadily over the last years, from EUR 7.5 million in 2010.

Bananas represent about one third of all tropical fruit imports (EUR 2.9 billion in annual average for the years 2012-14, in particular from Ecuador, Colombia and Costa Rica). Following categories are almonds (EUR 1.9 billion; mainly from the USA), hazelnuts (EUR 0.7 billion; mainly from Turkey) and pineapples (EUR 0.5 billion; mainly from Costa Rica). Cashew nuts are imported from Vietnam and India, and Avocados enter the EU single market in particular from Peru, South Africa, Chile and Israel.

Overall, the most important countries of origin for tropical fruit, nuts and spices imports are the USA (18% of all tropical fruit, nuts and spices imports; mainly almonds and pistachios), Cost Rica (10%, bananas and pineapples), Ecuador (9% with bananas being the most important product). These countries are followed by Turkey (8%, in particular hazelnuts), Colombia (bananas) and Vietnam (cashew nuts).

Most of the imports of tropical fruit, nuts and spices enter through Germany (19%), followed by the Netherlands (16%) and Belgium (14%). Other important importers are the UK, Italy, France and Spain.

EU imports of tropical fruit, nuts and spices (average 2012-14)

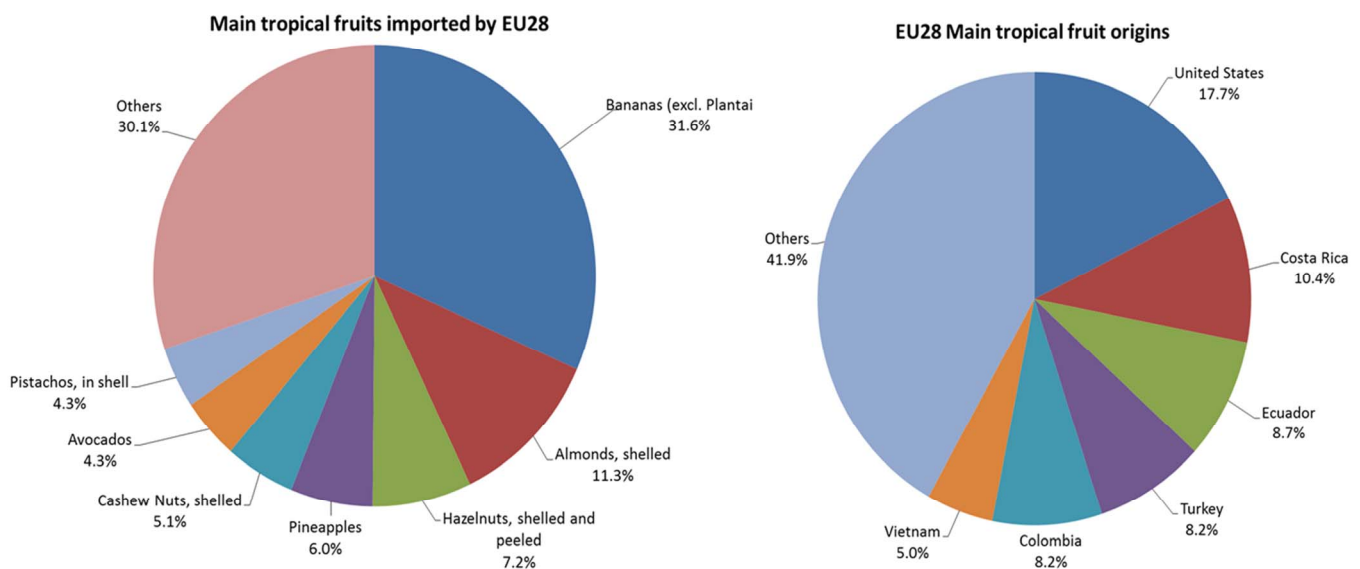
